1. The name of the society shall be "Agrawal Jatiya Shiksha Parishad". [Established Year 1916]
2. The object of the society shall be as follows:
  - (a) [To manage and develop, to raise and improve the status of Allahabad Primary School Renamed as Allahabad Vidya Niketan, Allahabad Inter College, Allahabad Lalitkala Academy , Allahabad Degree College and Allahabad Institute of Higher and Professional Studies also to open and maintain more educational institutions in and outside the District of Allahabad for imparting education moral, Technical vocational including higher education (Degree and Post-graduate Degree, Diploma courses) to boys and girls and to do all acts necessary or incidental or supplementary thereof.]<sup>1</sup>
  - (b) To impart education in various branches of knowledge including commercial and technical training.
  - (c) To maintain a library in connection with the Allahabad Inter and Allahabad Degree College or other institutions run by the society.
  - (d) To help the students by founding scholarships and awarding prizes for the encouragement of learning.
  - (e) To start, maintain and aid educational institutions outside Allahabad, and for this purpose to associate or co-operate with any other society or persons, and to incorporate any other educational institution and society.
  - (f) To manage all funds raised by subscriptions, donations, charity boxes, **rents**<sup>2</sup> or loans, etc. for the above objects to acquire by purchase, lease, gift, exchange, or otherwise any real or personal property and any right or privilege necessary or suitable for the purpose of the Association, to sell, improve and develop all or any part of the movable or immovable property of the Association.
  - (g) To adopt all such other means as are incidental or conducive to the attainment of the above objects.
